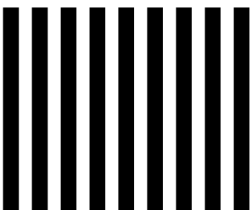

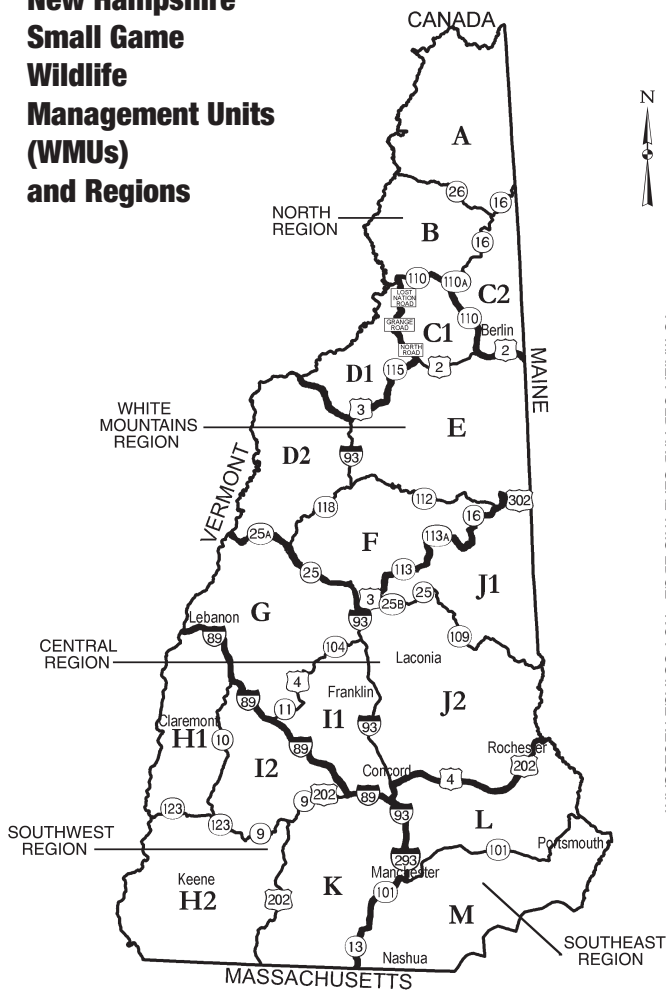

Dear Small Game Hunting Enthusiast:

By way of this letter, we are asking you to participate in our small game hunter survey that spans the period of 9/1/2024-3/31/2025. Your field observations will provide our small game project with valuable management insight into American woodcock, ruffed grouse (partridge), gray squirrel, cottontail rabbit and snowshoe hare. The data you collect will help us to: 1) determine small game distribution in New Hampshire; 2) compare small game abundance by region; 3) assess annual changes in abundance stemming from changes in productivity and mortality; 4) generate small game hunting season forecasts; 5) determine management needs; and 6) identify areas for possible habitat management.

THIS YEAR WE ARE PLEASED TO ANNOUNCE WE ARE HOLDING A DRAWING FOR A STURM RUGER 10/22 RIFLE FOR THOSE WHO RETURN A COMPLETED SMALL GAME SURVEY.

When filling out this survey, PLEASE ADHERE TO THE FOLLOWING GUIDELINES:

- Only record **YOUR 2024-2025 small game hunting** observations.
- The small game season can be divided into 2 reporting periods: September 1-December 31, and January 1 through March 31. If you hunt during both recording periods, please advise us of such and we will send a second survey.
- Enter your daily hunting observations sequentially. Your survey accommodates 14 days of hunting information. Feel free to make and submit copies of the survey if you would like to do so.
- Please return your postage-paid survey, after filling in all available days, by January 6, 2025, for fall hunting, or April 7, 2025, for winter hunting. **SURVEYS MUST BE RECEIVED NO LATER THAN APRIL 7, 2025, TO QUALIFY FOR THE STURM RUGER DRAWING.** Each hunter sending in a qualifying survey will be entered into the drawing only once each small game season (September 1, 2024 – March 31, 2025).
- If you don't see any small game when hunting, fill the appropriate column for that day with a zero.
- Include the Wildlife Management Unit (WMU) (*see map on the reverse side of this letter and on the back of the survey card*) and the town in which you hunted. Please do not list village names. We will NOT publish town results.
- Note that the last column on the survey is intended to identify the game species you were **"PRINCIPALLY HUNTING FOR."** If your principal pursuit was woodcock, place "WO" in the blocks, if it was gray squirrel place "SQ" in the blocks, etc. Note that the 2-letter abbreviation for each species of interest is highlighted on the survey form. Please do not include observations while pheasant hunting.
- **Only fill out the survey on days you are principally hunting one of the small game species we have listed.**
- If you have a friend who would like to participate in this survey, have them call (603) 271-2461.
- A brief summary report will be distributed to all survey respondents upon its completion.
